TEST OFFERED: FAST CAT TEST

FAST CAT Tests are open to all dogs at least 12 months of age that are individually registered with the AKC, recorded in the Foundation Stock Service (FSS) program, individually registered with a foreign or domestic registry organization whose pedigrees are acceptable for AKC registration, dogs granted a Purebred Alternative Listing (PAL) number, dogs with AKC Limited or Conditional Registration, or dogs enrolled in the AKC Canine Partners program. Dogs with breed disqualifications and monorchid/cryptorchid dogs are eligible to participate. Females in season may not enter. A dog may enter only once per event. (An event is defined by an event number.) **GO TO akc.org TO REGISTER A CANINE COMPANION.**The **FAST Cat** test is a timed 100 yard dash. The dog is released at the starting line by one person and then must be caught by a second person at the finish line.

TRIAL HOURS: 8 AM – 4 PM each day. ROLL CALL: Progressive Rolling Roll Call starting at 9:00 AM. All entrants should plan to arrive no later than 2:30 PM each day; to be checked in, in line and ready to run by 3 PM. Dogs not in line and ready to run by 3 PM may forfeit entries. Inspection starts 1/2 hour prior to roll call each day. At inspection, lame dogs or bitches 'in season' will be denied entry with a refund of entry fees. Each day the first test will start as soon as dogs are checked in & both tests will be run concurrently.

FAST CAT tests are divided into 3 categories dependent on the size of the dog. The size category is used in the calculation to determine how many points are awarded towards AKC FAST CAT titles based on the Mile Per Hour (MPH) of the dog's dash. Please indicate on your entry form if the entry is less than 12 inches, 12 inches but less than 18 inches, or 18 inches or over at the shoulder. If the height is questionable the inspection committee will measure to be sure.

These tests will be conducted with electronic timing. In the event of equipment failure, manual timing may be used. A continuous loop system will be used with white or colored plastic streamers for the lure. Back-up equipment will be available. Tests will be on Grass. Test area will be fenced.

AWARDS: Each dog passing FCAT will be offered a light blue ribbon. Rosettes will be offered for dogs completing a BCAT, DCAT and FCAT if the title is earned at these events. HANC offers a plush dog toy for the Sighthound & Scenthound with the highest MPH average over the four tests.
